<b>Participants:</b>	The <i>Forum's</i> Steering Committee welcomes up to 48 mass tort lawyers from the plaintiffs' bar, who specialize in pharmaceutical and medical device claims. Participants are personally selected based on experience and specialization in these matters.
<b>Our Format:</b>	The <i>Forum</i> is an "invitation only" meeting of elite litigators in this field. An Agenda, developed by the Steering Committee, forms the basis for the discussion and debate. The Chatham House Rule governs all discussion, allowing a free-flow of ideas and insights. The <i>Forum</i> does not feature traditional presentations, but is based on the participation of all those in attendance.
<b>Program Atmosphere:</b>	The <i>Forum</i> is an intense day-and-a-half of meetings. In addition to the sessions, there is informal time for talk and building relationships during the receptions and meals. This is not a "holiday" type of program. Spouses or significant others do not participate in the sessions, social events or meals.
<b>CLE Accreditation:</b>	Upon request, a certificate of attendance outlining participatory hours will be issued 8 weeks after the <i>Forum</i> has taken place. Hours are subject to jurisdictional approvals and requirements.
<b>Location &amp; Venue:</b>	The closest airport is Palm Beach International Airport (PBI) located 12 miles north of the hotel. Alternatively, Fort Lauderdale-Hollywood International Airport (FLL) is 42 miles south, or Miami International Airport (MIA) is located 63 miles south.
